# What is a Motor Vehicle Inspector?



A motor vehicle inspector is a uniformed civilian employed by the Missouri State Highway Patrol. These professionals are responsible for the administrative oversight of all official Missouri motor vehicle inspection stations and properly permitted inspector/mechanics around the state. Motor vehicle inspectors are trained in consumer protection salvage inspection duties in order to detect stolen vehicle parts and fraudulent title activities. Motor vehicle inspectors are responsible for inspecting every school bus operating on Missouri's roadways. They also field and investigate consumer complaints regarding the improper, incomplete, or fraudulent performance of a motor vehicle safety inspection. Motor vehicle inspectors are vital to the success of the Missouri State Highway Patrol and embody the agency's core values of *integrity, responsibility, respect, professionalism, compassion, resourcefulness, character, and commitment.*



## Highway Patrol Motor Vehicle Inspectors:

- Receive in-depth training on state laws and regulations, stolen vehicle identification procedures, school bus inspection procedures, and excellence in customer service.
- Assess the premises of all automotive businesses seeking licensure as official motor vehicle safety inspection stations.
- Complete periodic audits of official motor vehicle safety inspection stations and inspector/mechanics.
- Administer written and practical examination to individuals seeking licensure as inspector/mechanics authorized to perform motor vehicle safety inspections.
- Provide administrative oversight to the Gateway Vehicle Inspection Program (emissions) in St. Louis and various counties in the St. Louis area.
- Communicate effectively with inspection station personnel, co-workers, the general public, corporations, and government agencies.
  - Perform inspections on over 12,000 Missouri-operated school buses each year.
  - Provide resources, customer service, and training to Missouri pupil transportation professionals.
  - Assist all Missouri enforcement officers with the identification of stolen vehicles and vehicle components.
  - Perform VIN/Salvage examinations to detect cases of title fraud in Missouri.



## Minimum Application Requirements

- Be at least 18 years of age.
- Possess a high school diploma or equivalent. Prior automotive experience and/or completion of an educational program in the automotive field is preferred.
- Possess or obtain a valid driver license.
- Be of good character, with no pending felony charges or prior felony convictions, and no pending charges or prior convictions for crimes of moral turpitude (i.e., dishonesty, immorality, immodesty, etc.).
- Successfully complete the Missouri State Highway Patrol's Motor Vehicle Inspection Field Training Program.
- Successfully complete the Missouri State Highway Patrol's Motor Vehicle Inspection Basic Training School.
- Be able to perform the job duties of a motor vehicle inspector.
