POSITION SUMMARY:

This is skilled technical work in the repair and service of boats, marine motors, and related equipment with the Missouri State Water Patrol.

DESCRIPTION OF DUTIES PERFORMED:

(Any one position may not include all of the duties listed nor do the listed examples include all tasks which may be found in positions of this class.)

Diagnoses, evaluates, and repairs outboard and inboard/outboard marine motors; repairs and services boats.

Repairs and/or modifies trailers, all-terrain vehicles, and other equipment utilized by the Missouri State Water Patrol.

Designs and configures computer and electronic components to meet required specifications.

Modifies and installs electronic equipment.

Performs routine maintenance checks on boats, motors, and related equipment.

Maintains parts inventory systems.

Updates and maintains manuals and data center information.

Completes work orders and related documentation.

Exercises independence; work is reviewed through inspections and conferences; receives general administrative direction.

Performs other related work as assigned.

Comprehensive knowledge of all types of marine motors.

Comprehensive knowledge of electronics and test equipment used by marine mechanics.

Comprehensive knowledge of computerized motor systems.

Skill in the use of mechanical equipment.
