**<u>DESCRIPTION</u>**: This Building and Grounds Maintenance position is assigned to the Missouri State Highway Patrol's Fleet and Facilities Division. The official domicile for this position is Jefferson City, Missouri. This position is classified as non-exempt under the Fair Labor Standards Act.

<u>POSITION SUMMARY</u>: An employee in this position is responsible for the general care of Patrol buildings and grounds, to include housekeeping tasks, mowing lawns, snow removal, etc. Work is assigned and performed in accordance with established routines. Instructions are specific in nature and work is subject to close inspection during progress and upon completion.

<u>QUALIFICATIONS</u>: Building and Grounds Maintenance I: Graduation from the eighth grade.

Building and Grounds Maintenance II: Graduation from the eighth grade and possess at least one year experience as a Building and Grounds Maintenance I or comparable experience.

Applicants must also possess and maintain a valid driver's license and be at least 18 years old at time of appointment.

**SALARY RANGE**: (Semi-monthly) The minimum starting salary is \$955.50; however salary may be commensurate with experience.

<u>APPLICATION PROCEDURE</u>: Individuals interested in this Building and Grounds Maintenance position must submit the Patrol's on-line application prior to the application deadline. Resumes will not be accepted in lieu of the application. Interview boards are tentatively scheduled for the week of September 15, 2014. The tentative start date for this position is within 30 days of the interview.
