<u>QUALIFICATIONS</u>: Building and Grounds Maintenance I: Graduation from the eighth grade. Building and Grounds Maintenance II: Graduation from the eighth grade and possess at least one year experience as a Building and Grounds Maintenance I or comparable experience.

<u>SALARY RANGE (Semi-monthly)</u>: The minimum starting salary is \$955.50; however salary may be commensurate with applicable experience and education.

<u>APPLICATION PROCEDURE</u>: Individuals interested in this position must submit the Patrol's on-line application prior to the application deadline of October 31, 2014. Individuals who have previously completed an application must access their profile in the ACE system to re-apply.

Current employees who meet the minimum qualifications set forth in the attached job description may apply through the Human Resources Division by submitting an intradepartmental letter of application (SHP-15) and resume through channels prior to the application deadline.

Interview boards are tentatively scheduled for the week of November 10, 2014. The tentative start date for this position is within 30 days of the interview.
