**<u>DESCRIPTION</u>**: There are numerous CVE Inspector positions available within the Missouri State Highway Patrol. The official domicile for these positions will depend on the location of the scale houses within the assigned Troop Headquarters. These positions are classified as non-exempt under the Fair Labor Standards Act.

Applicants selected for these positions are required to work days, nights, weekends, and holidays. Working hours vary by location and will be explained in detail at the time of the interview.

Although there may not be an opening at each listed scale house, a hiring register will be maintained in the event that more positions become available and another class is conducted. <u>POSITION SUMMARY</u>: This is an entry-level position where the employee weighs and inspects commercial vehicles to detect violations of state and federal law and regulations that pertain to their operation. The employee must be able to accommodate shift work and working outdoors during inclement weather conditions. Work is performed under close supervision by a designated supervisor. An employee at this level will be on probation for at least six months.

**QUALIFICATIONS**: Graduation from high school or possess a GED, be at least twenty-one years of age at the time of appointment, and possess and maintain a valid driver license.

Must be able to successfully complete the eight-week Basic Commercial Vehicle Inspector training course, beginning on March 4, 2012, as approved by the Superintendent of the Missouri State Highway Patrol in Jefferson City, Missouri, as well as an on-the-job training program.

Uniformed civilian employees will not have tattoos or brands that a reasonable person would find offensive, such as tattoos or brands depicting or supporting criminal behavior, drug usage, nudity, profanity, promiscuity, subversive groups, bigotry, etc. Applicants will not be hired for uniformed civilian positions if they have any tattoos or brands on the head, neck, hands, below the upper six-inch portion of the arms, or any other part of the body which would be visible while wearing any official uniform.

<u>SALARY RANGE (Semi-monthly)</u>: The minimum starting salary is \$1,175.50; however salary may be commensurate with applicable experience and education.

<u>APPLICATION PROCEDURE</u>: Individuals interested in any CVE Inspector position within the specified Troops must submit the Patrol's on-line application prior to the application deadline of December 13, 2012. Resumes will not be accepted in lieu of the application. All applicants will only need to submit one application, even if they are interested in multiple locations. Each applicant meeting the minimum qualifications will be contacted directly to see which locations they are interested in working.

Current employees who meet the minimum qualifications set forth in the attached job description may apply through the Human Resources Division by submitting an intradepartmental letter of application (SHP-15) and resume through channels prior to the application deadline.

**TESTING AND INTERVIEW PROCESS**: A written examination and interview will be conducted at the Troop Headquarters in which the vacancies exist. The testing will take approximately two hours. Interview boards are tentatively scheduled for the week of January 7, 2013.

The start date for these positions is tentatively scheduled for March 4, 2013. On that date, the selected applicants will complete orientation at the Missouri State Highway Patrol General Headquarters in Jefferson City, Missouri, and begin the required eight-week training. Room and board will be provided to the selected applicants for the eight-week training course.

Some Patrol duties relate to criminal activity. Therefore, employees may be exposed to written material, photographs, and/or verbal language of a sexual nature. The requirements of this position are not intended to create a hostile work environment; however, it is work of an extremely sensitive nature. A copy of the Missouri State Highway Patrol policy on sexual harassment is available upon request.

**NOTE:** Final selection may be based upon several factors, e.g., results of an oral interview, written examination or exercise, review of past work performance, performance evaluations, and/or candidate's possession of the knowledge, skills, and abilities deemed necessary for successful performance in the job.

Once a job offer has been made, employment with the Missouri State Highway Patrol is contingent upon the successful results of a Patrol administered drug test and favorable background investigation.
