<u>QUALIFICATIONS</u>: Housekeeper I: Graduation of the eighth grade. Housekeeper II: Graduation of the eighth grade AND possess at least one-year experience as a Housekeeper I or comparable experience. Housekeeper III: Graduation of the eighth grade and possess at least one-year experience as a Housekeeper II or comparable experience.

SALARY RANGE: (Semi-monthly) The minimum starting salary is \$810.00; however salary may be commensurate with experience.
